Details:

2. This summary will appear directly under the heading, and “Assigned Date” / “Completed Date” for each measure (see screenshot below)

This 18-item scale evaluates behavioral problems over the past month covering key challenging behavior domains - including property destruction, aggression, elopement, conduct, and self-injury.

The CBS has a mean standard score of 100, with a standard deviation of 15 (average range of 85-115), with scores above 115 being in the clinically-elevated range and scores ≥ 130 indicating very high symptom levels.

Feature #2 CFQL-2: Add Preliminary Question for Financial QOL

Details:

1. This feature adds a new question to the parent workflow for the CFQL-2 questionnaire, in the Financial QOL section, where the parent is asked whether or not they are comfortable completing that section (see screenshots below)
